

BORONIA HEIGHTS STATE SCHOOL STUDENT DRESS CODE

EFFECTIVE June 2023

The Boronia Heights State School Parents' and Citizens' Association is in agreement that Boronia Heights State School is a uniform school and approves the enforcement of this uniform policy by the school's Administration and Teaching Staff. There has been an existing dress code at the school for many years.



The Boronia Heights State School Student Uniform Policy reflects the school community standards and all students are expected to wear the approved uniform with pride. The uniform promotes a sense of belonging and fosters mutual respect among individuals at the school by minimising visible evidence of economic, class or social differences. As well as conforming to current sun safety requirements, our uniform offers protection to our students by making them easily identifiable as Boronia students.

THE WEARING OF FULL UNIFORM IS COMPULSORY FOR ALL STUDENTS IN PREP THROUGH TO YEAR 6 AT ALL TIMES UNLESS OTHERWISE ADVISED.

UNIFORM REQUIREMENTS

- Boronia Heights State School polo shirt with school logo (royal blue, red & white).
- Royal blue shorts, skort or netball skirt (N.B. If students choose to wear bike pants/skins they must be worn *under* their shorts; *they must not be visible*).
- Royal blue wide brimmed or bucket hat with embroided school logo (red brimmed hat for Prep students).
- Closed in joggers or leather shoes with white socks.
- Royal blue long pants.
- Boronia Heights State School long sleeve polo shirt with school logo (royal blue, red and white).
- Royal blue jumper or jacket or Boronia Heights State School jacket with school logo (royal blue).
- Any additional items of undergarments that are being worn for warmth must not be visible; a *long sleeved skivvy is not to be worn under the short sleeved polo shirt.*
- Year 6 only commemorative short sleeve polo shirt (royal blue, red and white).
- On Sports Day students are permitted to wear a non-uniform shirt in their house colour.

Cultural or Religious requirements will be taken into account and be negotiated with school administration.

Items of clothing not mentioned in the above lists are not permitted to be worn to school. If there is an unexpected issue that results in a student being out of uniform, parents/carers must inform the school by way of a phone call, a written note or a personal visit. Substitute items of clothing must be as close to school colours as possible and in line with uniform standards; *denim clothing, mini skirts/shorts, singlet tops and non closed in shoes are unacceptable.*



Jewellery

• As jewellery can be dangerous to students involved in physical activities, minimal jewellery is to be worn to school. A wrist watch and small stud or sleeper earrings are acceptable. No other jewellery should be worn with the exception of a Medic Alert bracelet. No facial or body piercing is permitted.

Hair

• Hair that is shoulder length or longer must be tied back, regardless of gender. Hair dye is permitted only in cases where the dye is a natural colour close to the shade of the student's actual hair colour. Hair should be cut and styled appropriately with no extreme styles. The obvious use of hair product is discouraged. Hair accessories must be in school colours (royal blue, red and white). Coloured hair is not permitted, even on Sports Day.

Body Art

• Coloured nail polish, nail art, make-up or fake tattoos are not permitted. It is illegal for anyone under the age of 18 to have a permanent tattoo.

Please note that the Principal is the only member of staff who can give permission for a variation of this policy. Failure to comply with any part of the above policy will result in the implementation of the follow up actions outlined below.

Parents/carers are responsible for the provision and general maintenance of the uniform. It is also the responsibility of the parent/carer to clearly name all uniform items.

The Uniform Shop is located in the breezeway between the Tuckshop and the old hall. Opening hours are Mondays and Thursdays from 8:15am to 9:15am.

UNIFORM BREACH FOLLOW UP ACTIONS

At the beginning of each school day all class teachers will do a uniform check. The following action will be taken for any student who is in breach of the Boronia Heights State School Student Uniform Policy:

- If the breach involves a piece of jewellery, the teacher will ask the student to remove it and they will take care of it until the end of the day.
- If the breach cannot be immediately rectified by removing the clothing item or by having the student provided with a replacement clothing item, the student will be reminded about the specific requirements of the policy in relation to that particular infringement.
- If the infringement is a hat infringement, the student will be directed by their class teacher to play in an area where a hat is not required. (Senior school students Library, Computer Lab or Senior Games Room; Junior school students Library, Computer Lab or Junior Games Room.)
- If there are continual uniform breaches by the same student, the class teacher will notify the appropriate Deputy Principal who will follow this matter up with the student's parents/carers. An electronic record of this contact and the resulting outcome will be made. The class teacher will be informed of the resolution by the Deputy Principal. The class teacher will be asked to monitor the situation and report any further breaches of this agreement to the Deputy Principal. If the situation cannot be resolved it will be dealt with under the Boronia Heights State School Responsible Behaviour Plan for Students.

In one off cases where the parent/carer has submitted a note to explain the uniform infringement, no follow up action will apply.
